101 year old Witness in Murder Trial

Mike Abbott sent me an extract from the Daily Telegraph (23rd May) regarding a 101-year old lady witness in a murder trial. The lady in question was Liz Zettl, who many of the "more senior" members of South Mids and surrounding regions may remember from BRDC and other major events at Silverstone.

Liz was and is a true lady. She and Anne Pullen combined on race telephones at Silverstone for many years. Popular with everyone and widely known as "the ladies" who manned race phones at Silverstone. I am not sure exactly when Liz retired but I believe she was into her eighties before she did.

Three or four years ago I had the great pleasure to be sat next to Liz at a Doghouse charity dinner in the BRDC suite. Observing the adage, "One does not ask a lady's age", I did not enquire but was reliably informed Liz was in her late nineties.

Well, you would never have guessed that! Once she placed who I was ("Weren't you the Marshals' Club Treasurer for a while?") we did not have much to say to others around us. Dredging up all the names of times passed - Jimmy Brown (loyal friend of BMRMC), Tony Salmon, Pierre Aumonier and a load of other names I cannot now remember, but I bet Liz would!! I can see why the Judge made the remarks he did in the recent trial.

Guest Speaker at the Doghouse event was John Bercow, Speaker of the House of Commons. Despite the criticism we read of his alleged antics in the House, he gave a varied, interesting and very humorous talk that evening. He and Liz are near neighbours and he made many kind references to her in his speech.

Liz is believed to be the oldest witness ever to give evidence in a murder trial. The trial at which she was giving evidence concerned a nasty plot to kill and rob elderly people of their last few bob. We must be eternally grateful that they did not get to Liz. (DT article attached)

101-year-old witness in murder trial 'may have been next target'

BRITAIN'S oldest court witness yesterday gave evidence at a murder trial that heard she may have been the

Elizabeth "Liz" Zettl, 101, relived the moment she was told by police how two men on trial for killing a pensioner had a copy of her will.

The court was shown evidence that the defendants, Martyn Smith, her lodger, and his friend Benjamin Field,

had an emailed copy of the will.

Mr Field, 28, a church warden, and Mr Smith, 32, a magician, are accused Mr Smith, 32, a magician, are accused of conspiring to murder retired lecturer Peter Farquhar, 69, in Maids Moreton, Bucks. Mr Field is accused of attempting to murder retired teacher Ann Moore-Martin, 83. Both were allegedly targeted in a "gaslighting" plot.

Ms Zettl appeared in court as a video was shown of her police interview when she was told that Mr Field and Mr Smith had a copy of her will. She sug-

gested the only reason why Mr Smith may have a copy was because he had "scrawled" a telephone number on the back and needed the piece of paper. It is understood she is the oldest

person to ever give evidence in a criminal court. She told police her lodger was "absolutely no trouble".

The court heard police discovered

the will on Mr Field's university server as an email attachment which Mr Smith sent himself from her email address

The prosecution say this was so they could "see what she was worth".

After her evidence, Ms Zettl told Mr
Justice Sweeney: "Sorry it wasn't very
helpful but my memory's not as good
as it was." The judge replied: "If we're
all as bright as you are at your age, we
will have great cause to be grateful."

Mr Smith, of Penhalvean, Cornwall,
also denies three counts of fraud, one
of hurglary and one of possession of an

of burglary and one of possession of an article for use in fraud, namely Liz Zettl's will. Mr Field, of Olney, is additionally charged with one count of burglary, three of fraud and one of possession of an article for use in fraud also in relation to Ms Zettl's will.

He admitted the three fraud counts and the burglary. Also in the dock was Mr Field's brother Tom Field, 23, of Olney, Bucks, who is charged with fraud by false representation.

The trial continues.

HSCC Meeting 18/19th May

Then, we arrived home to an invitation to the HSCC meeting at Silverstone the following weekend. This came from Jonny Westbrook, who initiated what is now known as the Dunlop Saloon Car Cup series and whom we have known since he was a very young man.

A quite different meeting from last, with some fancy machinery on display. Full grids for every race on Sunday (good to see) and some great racing. Richard Kent, son of an exbusiness partner managed three podium places, including a first, but we missed all that because this was ex-programme.

Circuit Standards

This was our first "proper" attendance at a UK race meeting since I retired in 2014. Even before then most of my Clerking activities, for ten years or more, had been out of the country. Good to be back – and visiting Silverstone, after ten years or more around foreign GP circuits, how in Heaven's name can Silverstone come in for so much criticism. Silverstone facilities, in my view, are as good as, or better than anywhere in Europe. OK, there are some circuits with plusher admin offices and "hostility" suites (the bits the "high ups" see) but overall "my local circuit" is well-maintained, with excellent safety features, and a great bunch of marshals.

Have a look behind the scenes at some areas at Spa; they look like derelict building sites. June has a great photo of the *single* toilet for the main grandstand at Hungaroring, with a high cistern and a string pull chain. First time I went to Monza with Radicals Euro Series, we were directed to the VIP car park – grass about a foot high! Later that weekend a low-slung sports car came in, a bit hot from the Autostrada perhaps, and promptly set the grass on fire. For anyone who has attended Sebring lately, where they still run major sports car meetings, that circuit is hardly luxurious, for officials, VIP's or spectators.

So, let's hope this year is not the last F1 GP at a very famous track. Ross Brawn said in a recent TV interview that "no major circuit would drop off the list in 2020". Let's hope he meant it and Silverstone is able to continue without bankrupting the BRDC.

Lille Racewear Overalls

Amazingly 4 months have already passed since AWS closed and Lille Racewear became the new and sole supplier of proban overalls and it is timely to review progress.

We know some of you have found it difficult to contact Anthony as he is often on the road seeking new business opportunities but for the time being this is his preferred way of operating as he learns about BMMC marshals.

There have been some delays fulfilling orders due primarily to a combination of training a new seamstress, and a greater number of made-to-measure orders at a time of peak ordering. This should now settle down.

One issue on which Anthony seeks your help is ensuring you order the correct size overalls. Before telephoning to place an order please refer to the sizing chart on the Lille website – look under Marshals Suit BMMC – and ask someone to measure you! Self-measurement is invariably inaccurate.

Having been accustomed to the honed services of AWS over so many years some initial teething problems were to be expected but we are working closely with Anthony at Lille to resolve and move forward.

Lille Racewear is now the leading supplier of marshals overalls in UK with many other manufacturers struggling against cheap and inferior quality garments from the Far East and we therefore need to make this relationship work.

I would however suggest that any contact with Lille Racewear is carried out on a "direct" basis as previously advised.
