2022 has been a roller coaster of a year.

Autosport was again cancelled and events were disrupted up and down the country as the pandemic continued to cause nervousness. We are now living with it but COVID is here to stay and we must continue to recognise its potential effects on individuals.

We sadly said goodbye to two stalwarts of the club. Eric Ridler was our National Regalia Officer and played a long term role on the North West committee. George Copeland held the role of Treasurer for a number of years and latterly was a Vice President of the club. Both will be sorely missed.

Rob Mugurian stepped down as National Grading Officer and Mark Jarvis stood down as National Volunteering Coordinator.

We welcome Adrian Liddement in to the role of National Regalia Officer and Andrew Palmer in to Rob's role. Mark's role is as yet unfilled.

Our regional recruitment teams have done sterling work over the last few difficult years. Keeping in touch with potential new recruits during the pandemic was not easy. TREASURERS REPORT

AGM 4TH DEC 2022

[1] 2021 Unaudited Accounts:

Under Club Rules I am required to present suitably prepared annual accounts for the year ended 31st December 2021 as a matter of record.

The accounts, prepared by Booths Ainsworth have been approved at Council and duly filed at Companies House.

The full accounts and explanations are on our website, however I present below a synopsis of the accounts and explanatory narrative.

[2] 2021 Financial Performance:

This report provides a brief commentary on the key figures in the draft 2021accounts that have been filed at Companies House following the annual accountant's report and approval by the Council and ratified by the membership.

As reported last year, the full effects of the Covid lockdown would be affect this reporting year. The decision to reduce membership subscriptions by 50% was felt this year, although there were corresponding savings on expenses as many National and Regional meetings were held electronically.

What was pleasing was that the pent up desire to go racing meant that our two Sprints were very well subscribed – income was double that of the previous year and a small surplus was made on the events.

Also encouraging was the fact that not only have renewed all our current sponsors but we now have GGR Motorsport on board.

Therefore its pleasing to report that the Club showed a surplus of income over expenditure of £11,164 before depreciation of our assets, and £5,235 thereafter.

Income -

- There was no significant decrease in membership during 2021.
- What limited training undertaken was fully reimbursed by BMSTT.
- There was a smaller than usual surplus from subsidised clothing sponsorship..
- Our income from Sprints doubled to £17,460.
- Although the number of donations increased, their value was smaller than in 2020, however all were very welcome and provided over 60% of our surplus for the year. Expenditure –
- A slight increase in IT costs Zoom licences etc.
- As forecast last year, there was again a significant decrease in administrations costs.
- As there were only a small number of clothing subsidies not claimed our overall costs rose slightly to 83% of income (2020-81%)

The full surplus income has been retained increasing Balance Sheet reserves to £143,833 of which £127,575 is held in cash.

Year-end debtors are £8,125 and reflect sponsorship amounts invoiced prior to the year end. Almost £5,000 of these have been settled as at Jan 2022.

There are no other material issues to record.

[3] 2022 Performance:

As forecast last year, we have returned to the levels of profitability enjoyed pre-Covid and to date our surplus stands at £26,567.

We have had a new sponsor for our overalls in GRR Motorsport and a number of Clubs have donated funds this year. As marshals returned to the Bank this year, our income from overalls sponsorship has increased.

Our Training costs were well below that which Regions budgeted and requested from BMSTT, therefore the projected shortfall of £13,500 did not materialise.

[3] 2023 Forecast

A budget for 2023 will be presented to Council prior to our first meeting in 2023, however we have received our BMSTT offers and they are at 75% of that which we requested. However the quantum offered is significantly higher than in 2022.

On the assumption that our overalls sponsors will renew again, together with a new sponsor for our Sprints (REIS Insurance) then the Club should retain its profitability throughout 2023.

[4] Other Matters:

Bookkeeping.

Once again I am indebted to Colin Barnes who continued as bookkeeper and has contributed to the savings in administrative expenses by taking on this role, and has now developed an expertise in cloud based accounting. I thank Colin immensely for successfully taking on this role and all the advice and reminders he has given me.

Ordinary Resolution to be presented to the Annual General Meeting to be held on 4th December 2022 to modify Club Rules B1, B2

To amend the currently wording of the Aims and Objectives in the Club rules (B1, B2) Extract from Club Rules as published:

B.1. Aims:

· To recruit marshals

To maintain a continuous recruitment programme,

To train marshals

To provide training for members to equip them with the skills and abilities required by the Motorsport UK marshals grading scheme

· To retain membership

By providing exclusive benefits for members and maintaining a dialogue with them to ascertain how their marshalling experience might be improved

To liaise with other motor sport bodies

Keep up a regular dialogue with other motor sport organisers and with the relevant Authorities, to advise and negotiate upon all matters appertaining to marshals and their voluntary activities within the sport

To note and advise on circuit/course improvements

Use established local contacts at all race circuits and other motor sport venues, to note and advise upon suggested safety and work improvements

Database

Maintain an up-to-date database of members' names; record of marshalling qualifications (grades) and contact details, provide an online volunteering system for all types of motorsport events accessible by chief marshals from organising clubs

· Apolitical & Independent

In all matters, the Club should remain apolitical and independent in the views it expresses, and, in any dialogue, it has with other motor sports participants

B.2. Objectives:

- To maintain a body of members and to provide them with the opportunity to volunteer to act as officials at race meetings and competitions as required by organising clubs and organisations.
- To work in conjunction with Motorsport UK and the ACU in accordance with their General Competition Rules and the Supplementary Regulations of the promoting club.
- To provide training and tuition both practical and theoretical to enable members to improve the standard of their marshalling for the benefit of motor sport.
- To provide fully paid-up members with personal accident insurance while on duty at approved events additional to that supplied by the promoting club, subject to insurable limits on age and territorial cover.
- To promote motor competitions in accordance with the requirements of Motorsport UK. All such competitions promoted by the Club shall be held under the General Competition Rules of Motorsport UK and in accordance with any other requirements of Motorsport UK.

Proposal

To amend B1 Aims and B2 Objectives of the Club Rules with revised text as below:

Aims and Objectives

B.1 Aims:

To recruit marshals

Maintain a continuous recruitment programme,

To train marshals

Provide training for members to equip them with the skills and abilities required by the Motorsport UK (MSUK)marshals grading scheme

Members Database and volunteering portal

Maintain an up-to-date database of members' names, which includes but not limited to record of marshalling qualifications (grades) and contact details. Provide an online volunteering system for all types of motorsport events accessible by both members and the chief marshals from organising clubs

To retain membership

Provide benefits for members and maintaining a dialogue with them to ascertain how their marshalling experience might be improved

To liaise with other motor sport bodies

Keep up a regular dialogue with other motor sport organisers and with the relevant authorities, to advise and negotiate upon all matters relating to marshals and their voluntary activities within the sport

To note and advise on circuit/course improvements

Use established local contacts at all race circuits and other motor sport venues, to note and advise upon suggested safety and work improvements

Standards

To ensure that members of the club officiating or participating in events sanctioned by Motorsport UK will abide by the regulations pertaining to the event. Failure to do so might be considered prejudicial to the interests of the club in accordance with article 30 of the Articles of Association https://www.marshals.co.uk/wp-content/uploads/2020/12/BMMC-Articles-of-Association-Dec-6-2020-.pdf

B.2 Objectives:

- To maintain a body of members and to provide them with the opportunity to volunteer to act as officials at race meetings and competitions as required by organising clubs and organisations.
- To work in conjunction with Motorsport UK and others in accordance with their General Competition Rules and the Supplementary Regulations of the promoting club.
- To provide training and tuition on both practical and theoretical elements of marshalling to enable members to improve the standard of their marshalling for the benefit of motorsport.
- To provide fully paid-up members with personal accident insurance which is additional to that supplied by the promoting club, while on duty at approved events (subject to insurable limits on age and territorial cover).
- To promote motorsport competitions in accordance with the requirements of Motorsport UK. All such competitions promoted by the Club shall be held under the General Competition Rules of Motorsport UK and in accordance with any other requirements of Motorsport UK.

Ordinary Resolution to be presented to the Annual General Meeting to be held on 4th December 2022 to add clauses to the Club Rules

Proposal

To add the following new clauses to the Club Rules in respect of Length of Service of President and Vice President(s):

T. President / Vice President of BMMC - Terms of Reference

1/ Purpose of Roles:

The President is an honorary role and is appointed in an advisory capacity for the British Motorsports Marshals' Club (BMMC), to support the National Chair and council. The President does not necessarily need to be a current member of BMMC but will be granted honorary membership for the duration of their time in office. The aim of the role is to actively promote BMMC and influence motorsport on behalf of BMMC marshals. Vice Presidents will be appointed as required in an advisory role for the British Motorsports Marshals' Club (BMMC) to support the Club.

The Vice President is an honorary role, generally based on length of service. The Vice President must be a current member of BMMC. The maximum number of VPs is to be 4.

The President and Vice Presidents can attend meetings at the invitation of the Directors / Council, however do not have voting rights in respect of Council matters.

Any potential conflicts of interest, either at appointment, or that arise during terms of office should be advised to the directors at the earliest opportunity, and within a month of the potential conflict becoming apparent.

2/ Term of Appointment:

The Honorary President and Vice President(s) will be appointed by the National Council of the BMMC at its Annual General Meeting (AGM) for a period of three years. At the end of the three-year term, a further 3 year term can be considered, subject to agreement by both parties. The absolute maximum term of an appointment is 9 years, with the final term of office intended to support and mentor the next generation of VP's.

Potential suitable applicants for both roles will be identified by members of Council and asked to apply formally for the positions if the role is of interest, with applications considered by Council.

3/ General Responsibilities:

Honorary President

- To support the Chair and National Council of BMMC providing advice and guidance to National Council and committees when required / appropriate:
- With the agreement of the BMMC Officers to act as a representative of BMMC with external organisations in furthering policy aims and objectives
- To be a key ambassador for the sport, the National Council and BMMC
- In agreement with the National Officers: Represent BMMC at formal occasions

e.g. official functions and presentations

Attend and present at domestic events, both competitions and awards

Speak at events and to assist with communication with the wider motorsport community

Vice President

• To deputise for the President in carrying the roles defined above plus:

- With the agreement of the BMMC Officers to act as a representative of BMMC with external organisations in furthering policy aims and objectives
- To be a key ambassador for motorsport, BMMC National Council and BMMC

4/ Removal from office:

Resignation

The Honorary President and Vice Presidents may resign from Office by giving written notice of 3 months at any time. They may however remain members of the club after resigning.

Suspension or Removal from Office

If Council receives a report that the Honorary President and/or Vice President(s) have potentially committed a breach of Club Policy / Rules and / or Social Media guidelines the Secretary shall communicate the allegation to the individual and advise that a meeting of 3 representatives of Council (not Officers of the Club) has been called 14 days from the date of the communication to discuss the allegation and that there is period of 10 days (from the date of the communication) to present any defence. The meeting will take place either via face-to-face or an online medium, such as Zoom.

The representatives of the Council will meet to review all information presented, and if deemed in breach of Club Rules or Social Media guidelines may decide to suspend the individual from their role for a period of time commensurate with the offence or immediately request the individual stand down; such action requiring a 2/3rd majority of Council.

The Secretary will advise the individual of the outcome of the Council meeting within 7 days of the meeting.

All communications in the above process will be conducted by email unless the individual concerned has no email address, in which case the individual will be advised by tracked post.

The individual if removed from office, shall forfeit all rights in, and claims upon, the Club and its property.

Right of appeal

Any individual suspended or expelled from the Club will have the right to an appeal to the Officers of the Club. The individual will have 10 days to lodge an appeal and such information will be presented to a meeting of the Officers of the Club. If no response is received within 10 days, the suspension or expulsion will be enacted.

If the individual lodges an appeal a meeting of the Officers of the Club will be called at the earliest opportunity, however at the latest within 10 days of the secretary receiving the appeal. If, by voting, 2 of the 3 Officers of the Club uphold the decision of Council, the individual's suspension or removal from office will be confirmed with no further right of appeal.

The Secretary will advise the individual of the outcome of the meeting.

All communications in this process will be conducted by email unless the individual does not have a recorded email address in which case the individual will be notified by tracked post.

The individual if removed from office, shall forfeit all rights in, and claims upon, the Club and its property

Chairmans Report 2022

His influence on BMMC both regionally and nationally is incalculable. We are working with Eric's family to come up with a permanent tribute to him, so watch this space.

We have planted 16 trees at Oulton Park to commemorate and remember marshals who have passed away in recent years.

Committee met eight time this year both by Zoom and face to face. We have a full committee of ten members each fulfilling

New elements of marshalling, namely Pathway and the introduction of new lights at circuits means that we will have to approach our hobby in a slightly different way – for the better – I hope!

Circuit Improvements. I have met with Oulton Park management several times this year to discuss a broad range of subjects.

NW region has benefitted from a donation of £580 from the BRSCC XR Challenge Championship as a token of their gratitude to the marshals at both OP and Anglesey.

We were able to have a social event this year, courtesy of Mike Newton, Praga, Idola and Speedworks at Antrobus.

You will be aware that MSUK launched their Race with Respect initiative in 2022, providing a framework for five cornerstones to drive new socially minded standards of behaviour.

If any marshal is at the receiving end of any disrespect from a team or club officials please report the incident, in confidence, to the Chief Marshal or any member of the committee. Respect is a two-way process.

By the same token, MSUK have introduced a confidential support mechanism to allow an individual to raise concerns in a safe environment and that the concern will be treated with a professional manner and in confidence.

We have 69 female and 593 male marshals – as at November 2022, an increase of 52 over last year. My thanks go to Duncan Fitz Gibbons and his hard-working team to man – sorry person the recruitment tent, follow up on enquiries, book taster days and entice people to join the growing orange family, breathing new life and energy into the NW membership. We have some excellent new marshals this year. 92 attended taster days this year and 100 have joined this year.

Finally, my thanks go to each of our NW members for turning out in blazing sunshine, pouring rain, howling gales, and making sure that clubs have been able to run their meetings safely, even with small grids of cars they have maintained a high level of professionalism that I am proud to be a part of.

We have had some great feedback comments – which have been shared in newsletters and social media outlets.

However, it is unfortunate that 2022 has seen reduced marshalling numbers across many events, with the numbers of experienced marshals seeming to be decreasing. However, pleasingly all disciplines of the sport have thankfully been active this year and we have been kept up to date with the trials and successes of each area - rally, race, kart, speed and Hillclimb, through our regional committee members through meetings and newsletters. Annual summaries and feedback from each committee officer for the year will be included in our end of year newsletter and committee reports to supplement the AGM minutes, which will be uploaded onto our website.

South Midlands Region 2022 Annual Report

Chairman's Report

At last in 2022 we were freed from the constraints of Covid, but we were still facing the consequences.

Committee Matters Following the resignation of Malcolm Flippance as regional grading officer at the AGM in October 2020 we were faced with one vacant committee place to fill. At the AGM Ian Whiting expressed an interest in joining the committee and after attending some meetings as a guest agreed to take on the grading officer role. He faced a steep learning curve and the prospect of learning a whole new grading structure with the new Marshals Pathway and, with some help from Malcolm, has dealt with the challenges admirably;. For the first time in three years we started 2022 with a full committee. I am really pleased at how well this committee is working together as a team. I have attended nine committee meetings this year; one meeting was cancelled because not enough of the committee could attend to make it quorate, however we did receive reports from all members. This year we have organised two zoom Noggin & Natter evenings; one in March with Hugh Chambers and one in July with Peter Roberts. Attendance numbers were down on previous events; is this down to the quality of the guests or because everyone is a bit Zoomed out? We are happy to continue with these events if you let us know who you want to see; but be realistic and we will see what we can achieve.

Members Surprisingly regional membership has remained almost static as I am sure Glynn will report. I say surprisingly because we are aware of an overall drop in numbers due to marshals not returning to the sport after Covid. We are all aware that a number of colleagues did not make it; our sympathies and condolences go to their families and friends. In March I undertook what I hope will be an annual exercise of ringing round the South Mids members to find out how they are coping. Please make sure your contact details are kept up to date. Following last year's AGM we have invited our members to two Meet the Committee Zoom meetings to discuss the proposals for the New Marshals Pathway. They were quite lively events!

Council Matters I have attended all three BMMC Council meetings held so far this year, a fourth will be held before the National AGM. There has been a very full agenda at every meeting. The new Marshals Pathway has been very challenging largely because detailed information about it was slow in emerging. The series of Zoom meetings led by our national chair Nadine helped clarify expectations and the Motorsport UK consultation has resulted in something more acceptable. We have also been investigating how we might self-fund training in the light of significantly reduced support from the British Motor Sport Training Trust and how we can improve the data quality of our membership data base and volunteering database to facilitate members volunteering for events. The BTCC experiment in using light signals instead of flags has been quite contentious leading to a Lights Vs Flags debate which has led to a long exchange of emails. Our national secretary has commenced a review of the Club's Articles & Rules with a view to rationalising them. Finally, we are examining what contribution the Club might make to "Racing with Respect" and "Environment Conservation" initiatives put forward by Motorsport UK.

Finally, it is with deep sorrow that we say good bye to two stalwarts of the Club; George Copeland our erstwhile Treasurer and past Chairman of South Midlands and Eric Ridler our late Regalia Officer who both passed away in August; may they rest in peace.

BMMC Northern Ireland Region 2022 National AGM Report

Motorsport events returned to normal in Northern Ireland in 2022 following the problems incurred by the pandemic during the past two years. We had a very busy year with full championships all running to schedule.

With just 55 members on our books, the numbers are slightly down on previous years. This is perhaps understandable. After covid it would appear that many people do not wish to go marshalling every weekend as they had in the past.

We covered everything as usual in 2022....racing, sprints, hill climbs, karting and rallying. In the Northern Ireland Region we are all multi-task marshals. We are all united under the BMMC banner. That is how everyone knows and referrers to us.

Our rescue unit was busy during the year. While on standby at rally stage starts the unit creates a high profile for the club and is much appreciated by all members of the Association of Northern Ireland Car Clubs.

We continue to hold our monthly club meetings on Zoom. This format has proved popular with club members and as a result we will continue to use the facility for the foreseeable future. Let's hope the current economic climate will not have any adverse effects on proposed events in 2023. It is going to be a challenging year ahead for both competitors, organisers and officials.



The numbers requesting access to our Facebook page continues to grow currently around 1800 and increasing daily. We are looking at ways we can encourage some of these to become club members. However, we feel that most attention or at least as much should be aimed at the retention of existing members giving as much support and encouragement possible.

We are also holding our AGM over the same platform. My team have worked hard over the past year, raising the profile of BRMC, and supporting the membership. I have a meeting of the training team scheduled in the next few weeks to finalize dates and venues.

ZZTRAINING OFFICER'S REPORT for National AGMDecember 2022

The last year has seen a successful return to face to face training post Covid-19 in terms of the club organising and delivering some great events for our members and other marshals.

Despite the reduction in the amount of funding grants received through the BMSTT to support our training events, we continue to ensure that procedures and processes remain effective so that our cohesive work between regional officers, national officers, and the Motorsport UK teams can still provide great training experiences for our members and fellow marshals.

2022 BMMC Training Days

BMMC organised many training events in 2022 all of which received a 75% contribution from BMSTT (British Motorsports Training Trust – processed via Motorsport UK) towards costs. These events took place across our regions and the BRMC section.

Statistical data from the evaluation forms is still to be finalised, but feedback to date has been very positive with nearly all being rated as good or excellent overall.

I take this opportunity to thank all the Regional Training Officers and their supportive training teams for a fantastic job. It is often underestimated how much time, energy and creativeness goes in to the planning and organising of training days and the fact that these events have run smoothly, is testament to the professionalism and commitment of the teams – well done to all of you!

Planning for 2023 BMMC Training Days

At the time of writing this report, the BMMC is already making headway with planning events for 2023, which also includes the receipt of BMSTT funding to cover the costs.

Regional training teams are awaiting news from Motorsport UK with regards new modules to support the new Marshals' Pathways, before finalising plans for the face-to-face events. Many of the standard module presentations are thought to be moving to the online training platform, for marshals to complete via independent study – leaving way for training day events to focus on practical and more interactive training. So keep an eye out for further information and please be supportive of your training teams who are adapting to new methods too.

In addition, further training days are being organised with a Train the Trainers approach, to help support the training teams to develop course content, presentation skills and the resources/activities used in events.

In Summary

It has been another busy year, which is not yet over as the training teams are already headway into arranging the next as you can see above. We continue to liaise with stakeholders regarding Fire Training, which takes into account Environmental Risks, Personal Protective Equipment requirements and safety advice and also dealing with Hybrid and Electric vehicles, as well as other emerging changes/factors. This may mean that some changes have to be made to the way things have been done before, but I know that the club and the training teams will be working together to ensure that we continue to provide training as effective and realistic as we can within the constraints.

Our trainers are constantly reviewing practice, sourcing video clips to demonstrate issues or good practice and work tirelessly to do this, so again, on behalf of all marshals, I express our thanks to them.

I cannot express enough, the benefit and importance of all marshals attending a training day — to not only update and develop their own skills (and not just to receive an upgrade signature) but to share their experiences with others and to support and mentor all marshalling colleagues.

I look forward to continuing to develop a collaborative and cross-regional approach to training in order to enhance, improve and expand the training we provide to all our existing and potential new club members.



26.1. Annual Regalia Sales.

Regalia sales data YTD until the end of October 2022;

Total regalia sales as reported on the Management Accounts are £2,154. This equates an increase of £1,129,00 110.04% as reported on the same YTD accounts in 2021.

Regalia sales by region to 31st October 2022



The above data shows that 31% of the sales has been generated by national sales and 34% generated by the Northeast region. However overall sales are low in regards to the number of members. This year so far only 462 items of regalia have been sold to members. If we assumed that the sales ratio was one item to one member this would mean only 18.1% of the membership made a purchase.

26.2 Aims & Objectives

New aims and objectives have been submitted to the National Council for 2023 as follows;

- Source BMMC approved regalia and merchandise from current and new suppliers.
- Managing new and current supplier relationships, agreeing, and negotiating supply agreement and ensuring that agreed service level are maintained.
- Be BMMC point of contact for all suppliers.
- Ensure Regional Regalia Officers have sufficient stock of regalia items to fulfil their region requirements.
- Introduce an eCommerce platform for the sales of club regalia and merchandise to ensure that club members have better accessible to club branded items and in turn increase club funds from regalia sales.
- Actively promote club regalia and merchandise through advertising on social media, club newsletters and other platforms.
- Actively promote BMMC and participate in National activities.
- Communicate with Regional Regalia Officers and club member in person and via newsletter.

26.3 Teamwear:

Despite attempts by both email and telephone, I have not been successful in making contact with our account manager at Best Workwear, unfortunately at the time of writing this report I am unable to confirm any sales information for the Teamwear.

26.4 Subsidy Claims:

As at the end of October there has been £27,057.50 of subsidy claims paid out overalls and £1,970.00 wet weather clothing, giving a total of £29,027.50. This equates to £11.39 per member.
