



## BRITISH MOTORSPORTS MARSHALS CLUB LTD. Environmental and Sustainability Policy

British Motorsports Marshals Club (BMMC) is committed to the achievement of outstanding environmental performance and sustainability in our operations. As a volunteer led organisation with direct links to motorsport, this policy outlines our approach to reduce our carbon footprint, measure our environmental performance and to help protect the environment to make sure we can leave a better, sustainable, long-lasting legacy for future generations of marshals to enjoy.

BMMC recognises that managing the environmental impact of operations is essential and with recent donations and fund raising for marshals being done, we as an organisation have to show some responsibility for the funds we hold and the funds donated to us.

BMMC makes the following commitments both in respect of its own activities and, where appropriate, in its influence over the wider community:

1. Establish clearly defined environmental objectives and targets and maintain continuous improvement by reviewing policies and strategies to ensure integration of sustainable management principles and practices.
2. Ensure that environmental issues are communicated and training is provided to all relevant stakeholders.
3. Comply with relevant environmental regulatory requirements.
4. Monitor and measure environmental performance
5. Identify and manage environmental impact areas that are relevant to BMMC.
6. **Carbon emissions and climate change.** BMMC will donate an environmental levy annually from events to offset the carbon emissions produced by BMMC members attending.
7. **Resource use.** Identify main areas of use and reduce where possible.
8. **Transport.** BMMC to identify main transport impacts and reduce where appropriate e.g. lobby circuit owners to provide charging points for EV's and consider car sharing when travelling to events.
9. **Waste management.** Make every effort to eliminate and reduce waste wherever possible from all events. Using recycled materials and recycling will be promoted wherever possible.
10. **Noise.** Motorsport UK legal noise levels are required at all time and BMMC ask for members to drive considerately whenever on the public road and in sensitive built up areas.
11. **Water consumption.** Identify main areas of consumption and reduce where possible.
12. **Pollution.** To prevent environmental harm or pollution incidents at all sites, by ensuring our working practices comply with all relevant legislation.
13. **Biodiversity and heritage.** Identify any risks to biodiversity/heritage and reduce our impact wherever possible.

To meet these commitments, BMMC will:

- Use this policy as a framework for setting objectives and targets for environmental improvement.
- Operate a procurement policy that conforms to these objectives.
- Operate effective management of environmental impacts.
- Communicate the requirements of this policy to all members, suppliers and partners.
- Make this policy publicly available and publicly report our environmental performance.
